Regulation

Accreditation Criteria

Pre-Accreditation

When applying for Pre-Accreditation, all forms sent to us must be NAPCP forms. We do not accept Supervisor reports completed for colleges. All criteria can be found below.

Pre-Accreditation Criteria

Supervision

In order to become accredited for the first time and also to renew accreditation, here are some points to note:

- Supervision must be with a Supervisor who has supervisor accreditation with NAPCP, IACP, APCP, IAHIP, BACP, BCP, ICP or ACI.
- Supervision should be at least once a month.
